The Chief Conservator of Forests (T.), Kolhapur vide reference No.1 has submitted the proposal for diversion of 3.7835 ha. reserved forest land under the forest (Conservation) Act, 1980 of Village Kumbharoshi, Jawali, Haroshi and Malkampeth, Tal. Mahabaleshwar, Dist.Satara for Mahapratap Ropeway Mahabaleshwar in the State of Maharashtra. The area statement of the proposed forest land is shown as under:-

- 2.0 In this context, it is submitted that the Chief Conservator of Forests (T.), Kolhapur vide letter under reference No.1 requested that the said proposal may be rejected. He has also mentioned in Part-III is that 'as the proposal is coming up in the Mahabaleshwar-Pachgani Eco-Sensitive Region, the said proposal is not recommended'.
- 3.0 Nodal officer on 02/03/2022 had requested the Chief Wildlife Warden to offer their remarks in accordance with the rejection recommendation conveyed by the Chief Conservator of Forests (T.),

Kolhapur. The Chief Wildlife Warden vide office note under reference No.2 has conveyed his remarks as follows:-

'In the present case, the recommendation of the Chief Conservator of Forests (T.), Kolhapur about the rejection of the said proposal seems to be correct. Therefore, the said proposal is not recommended by this office.'

4.0 After observing the above facts, this office agrees with the opinion of the Chief Conservator of Forests (T.), Kolhapur & the Chief Wildlife Warden. It is therefore the said proposal is recommended to be rejected.
