Subject: Proposed forest land diversion of 0.84 ha with felling of 201 number of trees for Establishment of Toll Plaza on Faizabad-Allahabad NH 330 (Old NH 96) between km 12.600 to km 12.950 in Faizabad District of Uttar Pradesh-reg.

Sir,

In reference to your above mentioned letter where approval for above referred proposal was sought; I have been directed to convey following shortcomings of the proposal for necessary rectification:

1. Reasons /Justification of location of toll plaza at the proposed site are not provided with the proposal.
2. The alternatives of locating the toll plaza analysed/examined and there results have also not been provided with the proposal.
3. The uploaded Survey of India topo sheet and geo referenced map for proposed forest land diversion has not been authenticated by the concerned District level forest official.
4. Forest land gazette notification is not legible, un authenticated and the concerned portion of notification relevant for the proposal has not been marked/highlighted.
5. The forest area calculation submitted with the proposal is incorrect and is not as per the layout plan.
6. The information provided at Sr no.13(i) part II shows proposed compensatory afforestation on equivalent forest land which is contradictory to provisions contained in para 3.2 of Handbook of FCA. The Compensatory Afforestation Scheme should conform to the guidelines provided.
7. The location of proposed CA is linear strip of the same road which may be widened in future and thus needs revision.
8. The language of certificate under FRA 2006 enclosed with the proposal is not as per format.
9. The legal status of forest land has not been mentioned in Site Inspection Report submitted with the proposal.

Therefore, the proposal is hereby placed under EDS category for rectification/revision of the same as per the observations made above in point wise manner.




