विषय:— जनपद—पिथौरागढ़ में माननीय घोषण संख्या 1732/2015 के अन्तर्गत विधानसभा क्षेत्र डीडीहाट के अन्तर्गत अरकोट से कूटा मोटर मार्ग निर्माण हेतु 4.915 हैं0 वन भूमि का गैर वानिकी कार्यों हेतु लोक निर्माण विभाग को प्रत्यावर्तन किये जाने के सम्बन्ध में। (Online No. FP/UK/ROAD/31411/2018)

महोदय.

उपर्युक्त प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव में निम्नलिखित कमियां पाई गयी है। अतः राज्य सरकार निम्नलिखित बिन्दुओं पर आवश्यक सूचनायें प्रेषित करने का कष्ट करें, ताकि अग्रिम कार्यवाही सुनिश्चित की जा सकेः–

- 1. It is seen that 0.28 ha area selected for muck disposal in forest area. State Government is requested to avoid forest area for muck disposal and select some non-forest land for this purpose.
- 2. On perusal of KML file of the proposed area, it has been noticed that village *Dewal* is already connected with the road. State Government is requested to submit the details of remaining habitation, their population and path distance from the nearest existing road.
- 3. Details of 631 trees to be enumerated found uploaded at para 4 in Part II and in tree enumeration list. However, it has been mentioned in the justification that tree counting done in 9 m width. State Government is requested to submit the tree enumeration list in 5.2 mtr width and at curve 6.1 mtr width as the area is very dense and population is less in the area.
- 4. Details of alternate not found uploaded at para D (ii) (a). State Government may submit at least three alternate in this regard to minimize the number of trees.
- 5. State Government is requested to upload/ submit the Village Level Committee meeting proceedings of each village separately.
- 6. Letter number and date is not found mentioned in FRA certificate of District Magistrate. State Government may do the needful in this regard.
- 7. Date of meeting of District Level Committee is mentioned as 21.08.2018 and 26.12.2017 in two different documents, State Government may clarify this.

- 8. As per DSS analysis of CA area proposed in civil soyam land, 6 ha area found in VDF and 2 ha in MDF. State Government may submit the list of trees standing in the CA area and submit the site inspection report of the concerned DFO.
- 9. State Government is requested to check the rate mentioned in the CA scheme which does not appear to be correct.
- 10. Documents uploaded at L (iv) g & h are not correct. State Government may upload the correct documents at L (iv) g & h in Part I.
- 11. CA scheme uploaded online in Part II is not properly scanned. State Government may upload a clear copy of the CA scheme.
- 12. Aerial distance of the proposed area from the nearest wildlife sanctuary is mentioned as 470 mtr. State Government may submit the comments of CWLW in this regard.
- 13. In view of the above point no. xii, details filled at para 8 seems not correct. State Government may direct the DFO to verify and fill the correct details at para 8 in Part II.
- 14. Density is mentioned as 0.3 for 631 trees in 4.915 ha area which does not appear to be correct and may be corrected.
- 15. Tree enumeration list uploaded online in Part II is not properly scanned. State Government may upload the clear and complete copy of the tree enumeration list online.
- 16. Details of trees mentioned at para 4 in Part II are not matching with details mentioned in the tree enumeration list uploaded in additional documents. State Government may provide clarification in this regard and remove this discrepancy.
- 17. Administrative approval and CA site suitability is not found uploaded, which may be uploaded.
- 18. Following shortcomings are noticed in the muck disposal plan. State Government is required to make the necessary correction accordingly:
 - (a) State Government is requested to mark the muck disposal site in KML file.
 - (b) State Government may clarify whether 0.28 ha area selected for muck disposal is enough for the purpose.
 - (c) Swell factor is not found calculated in the muck disposal plan.
 - (d) It is seen that 6 sites of non-forest area mentioned in muck disposal plan are not included in component wise breakup at para B 2.4 in Part I, which may be done.
 - (e) Total debris is mentioned as 1,26,000 cum out of which 86,792 cum mentioned to be consumed but balance calculated is 26,460 cum which is incorrect and seems not verified by DFO also. However, muck disposal plan of only 34,425 cum is submitted instead of 39,208 cum. State Government may submit clarification and submit the correct muck disposal plan.
 - (f) State Government is also requested to submit the reclamation plan.
