Diversification of 1.86868 ha of forest land in favour of Director of Technical Education, Vocational & Industrial Training, HP, for the construction of Govt. Polytechnic College, within the jurisdiction of Ani at Luhri Forest Division, District Kullu, H.P.

सन्दर्भ:

Online proposal no FP/HP/Others/147489/2021 received on 23.12.2023.

महोदय,

मुझे आपका ध्यान उपर्युक्त विषय से संदर्भित पत्र की ओर दिलाने का निर्देश हुआ है, जिसमें वन (संरक्षण एवं संवर्धन) अधिनियम, 1980, की धारा- 2 के अनुसार गैर वानिकी उद्देश्य के लिए 1.8686 हेक्टेयर वन भूमि की मांग की गई है।

2. राज्य सरकार द्वारा इस कार्यालय के समसंख्यक पत्र दिनांक 25.11.2023 के अनुपालन में भेजा गया स्पष्टिकरण पूरी तरह से स्पष्ट नहीं है, अतः प्रस्ताव के से सम्बंधित जानकारी भेजने का कष्ट करे: --

1. In the KML residential components i.e boys and girls hostels are mentioned however same is required to mention in the component wise breakup. Since, as per Para 1.10 of Consolidated Guidelines and Clarifications on Van (Sanrakshan Evam Samvardhan) Adhinyam, 1980 and Van (Sanrakshan Evam Samvardhan) Rules, 2023, MoEF&CC "Utilization of forest area for establishing industries, construction of residential colonies, institutes, rehabilitation of displaced persons, etc. are non-site-specific activities and cannot be considered on forest land as a rule. For that matter, no non-site specific proposal can be entertained for considering approval under the Van (Sanrakshan Evam Samvardhan) Adhinyam, 1980".
2. In the KML file boys and girls hostel are proposed however same is not included in the component wise breakup. The component mentioned in the KML should be mentioned in the B-2.1 component wise breakup with correct area details.
3. State Govt. may provide the copy of administrative and financial approval of the instant proposal duly authenticated by competent authority.
4. Since proposal proposed on hilly terrain and involves felling of large No. of trees as well as per Site Inspection report of DFO, Steep slopes are needs to be protected. Therefore, State Govt. may provide details of the mitigation measures to be adopted to arrest the accelerated soil erosion/land slide during/after execution of project. Additionally, the State Govt. may submit Soil and Moisture Conservation Plan as per para-1.22 (ii) of the Van (Sanrakshan Evam Samvardhan) Adhinyam, 1980.
5. State Govt. may provide the detailed and legible Scale Layout plan & structural design (length/width/height etc.) with detailed components in distinct colours

- with area proposed for each components in layout. Same shall be duly authenticated by DFO concerned.
6. DGPS map of the proposed Diversion area with all component, duly authenticated by DFO concerned is required to be submitted.
 7. State Govt shall provide the detailed and factual Joint Inspection Report (JSIR) by the concerned authority.
 8. In the Muck management plan it is submitted that the generated muck would be dumped in the dumping sites. Moreover, as per undertaking it is submitted that the generated muck would be utilized in the levelling of the sites. However, as per the Site Inspection report of the DFO, it is submitted that :
 - I. Ensure that no muck/debris is thrown/dumped on the forest land situated on the downhill side of the proposed side. The muck be dumped on the designated dumping sites only and its rolling down be stopped effectively.
 - II. Before initiating the work the dumping sites be prepared by erecting protection walls to avoid rolling down of debris to the forest situated on the downhill side of proposed road.
 - III. The excavation is carried out in scientific way to avoid rolling down of stone etc.

Therefore, State Govt/User agency is required to justify the contradictory statement and also provide the details of muck dumping sites and muck management plan with undertaking to abide by the conditions as stated by DFO concerned.

9. State Govt. shall provide the detailed justification with facts for establishing the project site in the proposed forest land duly authenticated by DFO concerned at sr. No-D, part-1 of PARIVESH portal.
10. State Govt may provide the details of purpose wise and component wise khasra No. for all the components in forest land may be provided.
11. State Govt shall provide the complete tree enumeration/Abstract of tree details with khasra number and date of enumeration as filled in the Sr. No-3 (ii), part-II of PARIVESH.
12. State Govt shall provide/upload the undertakings from IPH, HPSEB/HPTCL/HPPWD duly authenticated by concerned competent authority.
13. In the proposal no circulation area/opened area has been marked in the proposal. State Govt may clarify how much area is opened/circulation area. Also, provide the details of standing trees in this component.
14. State Govt is required to upload the legible copy of the recommendation of Concerned CF in Sr. No-16, part-II.
15. In State secretary recommendation part, Sr. No-17, part-II, recommendation of other proposal has been uploaded. State Govt shall provide the legible and correct letter of recommendation of State secretary.
16. Large numbers of trees and sapling (Total 142 no.) including ecologically and economically important species of (Cedrus Deodara, Pinus Wallichiana) are proposed for felling. Therefore, possibility of reducing the numbers of trees to be affected may be explored or rationalization to be done in the layout of the proposal to reduce green felling especially of Deodar and Kail trees.
17. State Govt Shall provide the certificate of non-availability of NFL as per format in SCHEDULE -III from Chief Secretary for proposing DFL under special provision Para 2.2 (iv) of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and Van (Sanrakshan Evam Samvardhan) Rules, 2023, MoEF&CC.
