Sir,

With reference to the above mention subject and letter under reference, undersigned is directed to inform you that proposal needs further clarification. Accordingly, I am directed to request you to submit following information/ documents :

1. No objection certificates of concerned departments (Irrigation, etc) shall be submitted.
2. Area calculation sheet shall be submitted.
3. Detailed muck calculation and muck disposal scheme as approved by concerned DFO shall be submitted.
4. Advisories shall be issued to all concerned officials responsible for violation of Forest (Conservation) Act, 1980.
5. It appears from the KML files that certain patches are missing from demarcation as forest. This needs clarification and subsequent rectification of necessary documents shall be submitted.
6. Also KML file of entire route, demarcating both Forest land and Non-forest land shall be submitted & uploaded on webportal.

Further, necessary action will be carried out after receipt of above information.
