उपरोक्त विषयान्तर्गत सन्दर्भित पत्र का आशय ग्रहण करते हुए मुझे आपको यह सूचित करने का निर्देश ह्आ है कि प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरांत निम्नानुसार कार्यवाही राज्य सरकार स्तर से अपेक्षित पाई गई

- 1. The NoC of Panchayat 'Tarswan' is given while beneficiary villages shown in B2.3 are Khariyan. Mathi Bajgaan and Cheling. Therefore, the comments of State Govt. is required in this regard.
- 2. The area in component wise breakup may be mentioned as separate for the following components (i) dumping site IV and V (ii) Bridge.
- 3. The power house is proposed over village 'Tikken' but it is not clarified that the construction of power house is part of this project or not because no such component is seen. Therefore, the state govt. gave the proper justification in this regard.
- 4. State Govt. may submit the T/L details i.e. how much area falls in forest land and how much in private land etc with proper evacuation plan duly authenticated by component authority.
- 5. The state govt. may mentioned the scientific names of tree enumerated in online portal at para 4 (ii).
- 6. The State Govt. may provide details of trees to be felled and not to be felled out of total 197 trees. The separate enumeration for trees in area proposed for muck dumping also be submitted by the state govt.
- 7. There is possibility to shift the dumping site in the non-forest land. Therefore, the state govt. may identify the non-forest land for dumping and the reasons for not selecting NFL for dumping may provide in detail dully authenticated by DFO.
- 8. The State Govt. may provide comments over river basin study of the catchment if any, being carried out in order to assess the total capacity and the potential of the basin to generate power.
- 9. State Govt. may submit the Implementation Agreement and Techno-Economic Clearance to this
