महोदय.

उपर्युक्त प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव में निम्नलिखित कमियां पाई गयी है। अतः राज्य सरकार निम्नलिखित बिन्दुओं पर आवश्यक सूचनायें प्रेषित करने का कष्ट करें, ताकि अग्रिम कार्यवाही सूनिश्चित की जा सके:—

- 1. On perusal of KML file of the proposed area, it has been noticed that villages are already connected with the existing road. In fact some alignment of the proposed road going over the existing road. State Government may submit the justification of the proposed road and requirement of the road.
- 2. State Government may submit the path distance of the villages form the nearest existing road.
- 3. State Government is requested to mark the alternate alignment in the KML file of the proposed area and upload the same at para C in Part I online.
- 4. State Government is requested to submit the details of the existing road, any approval under FCA obtained earlier and from where this road is starting.
- 5. Details of alternative alignment uploaded at para D (ii) (a) is found incorrect. State Government may submit the details of alternate alignment at para D (ii) (a) in Part I online.
- 6. Date is not found mentioned in the Village Level Committee meeting proceedings of *Pawn* village, which may be submitted.
- 7. Name of the CA area not mentioned in the documents uploaded at para L (iv) f, g & h. State Government may upload the documents at para L after mentioning the name of the proposed CA area.

- 8. State Government is requested to upload the clear copy of the CA scheme, CA site suitability, land schedule, bar chart and aerial distance certificate in online Part II.
- 9. State Government is requested to upload the CA scheme mentioning the name of the area proposed for CA.
- 10. Details of girth wise trees mentioned at para 4 in Part II are not matching with details mentioned in the tree enumeration list uploaded in additional documents. For e.g. 80 saplings mentioned in 0-10 in tree enumeration list uploaded in additional document but details of only 12 filled in 0-30 cm. State Government may remove this discrepancy and submit the correct information/documents.
- 11. Following observations are noticed in the muck disposal plan. State Government may made necessary corrections and submit the correct information/ documents in this regard:
 - (i) State Government may mark the location of muck disposal site in KML file.
 - (ii) Total debris is mentioned as 22,500 cum in 5 KM length which does not appear to be correct. State Government may verify the same.
 - (iii) It is seen that 93% of muck is mentioned to be used in the construction which does not appear to be correct. State Government may verify the same and submit clarification/ justification.
 - (iv) Area of 6 muck dumping sites mentioned as 0.068 ha in muck disposal plan at however, the total of the area comes to 0.113 ha. State Government may clarify this discrepancy.
 - (v) State Government is also requested to submit the reclamation plan.
