Sir,

I am directed to refer to State Government's letter No.1725/Section-II/2022/1801428 dated 24/04/2023 on the above subject. In this regard, it is informed that though the User Agency has identified non forest land for Compensatory Afforestation to an extent of 5.16 ha. in Mettupalli village, the CA scheme has been prepared by Forest Department for 4.20 ha. only. It may be noted that as per the guidelines issued by Ministry vide letter No.FC-11/151/2022-FC dated 25/09/2023, provision of raising Compensatory Afforestation will be applicable for the entire forest area proposed for diversion. It is, therefore, requested that the revised CA scheme may kindly be prepared and furnished for further processing of the proposal.
