The status of compliance is as under –

**Digital Map (in \*.kml file):** the digital map (in \*.kml file ) has been provided in poly-line format (having 3438 polygons) due to which analysis of digital map on Digital Support System is not possible.

You are therefore requested that digital map (in proper \*.kml, \*.shp file) may be submitted. In this connection, a detailed letter II/FC/RoC/95/2011/Part V/1229 dated 5<sup>th</sup> Feb 2016 has also been issued, a copy of which is attached.

Sub: **Requirement of Digital maps-analysis by DSS in FCA cases**

Sir,

As you are aware, Decision Support System (DSS) based on GIS has been put in place in this office by MoEFF&CC in association with Forest Survey of India and all the digital maps submitted with FCA cases are to be put to test on DSS.

It is brought to your notice that:

- 1) Digital maps submitted with hard copy are required to be submitted in .kml as well as in .shp files. Each .shp file should be accompanied with all associated supporting files like .prj, .shx, .dbf etc
- 2) Separate digital map files for Compensatory Afforestation (CA) and Forest land to be diverted (FLD) should be prepared and named accordingly.
- 3) The polygons for CA and FLD need to be specified and kept in different folders specifying CA and FLD as its name.
- 4) It has been observed in past that in many FCA proposals one major polygon has been sub divided in to hundreds of small polygons making it almost impossible for any kind of analysis by DSS. Extra polygons create unnecessary complications. Thus the digitization done for CA and FLD should be proper and crystal clear.
- 5) If the CA/FLD is located at different places then digital maps for each location should be given in different files to facilitate analysis by DSS. If for any reason one .kml file has multiple polygons then different IDs for these polygons must be mentioned so that in result of analysis a particular polygon can be referred to. In such cases reasons for making multiple polygons will have to be explained. If no reason is given, multiple polygons will not be accepted.



- 6) If for any valid reason (to be clearly recorded) any project has been segregated into different parts, then multiple polygons can be acceptable but the sequential alignment must be maintained in such a way that a single polygon can be obtained if all the sectors are merged.
- 7) The CD/DVD containing the digital maps must have details of maps written with marker pen.
- 8) The CD/DVD must be kept in CD/DVD jacket and properly secured with the file. It should not be kept loosely to avoid misplacement.

The above requirements may be brought to the notice of all user agencies and DCFs. CD/DVD must be checked by you before recommending the case.
