Sir,

Please refer to letter No F.6-1071/Land/For-2015/Pt-I/1395-403 dated 18th, February, 2022 on the subject mentioned above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. The proposal forwarded by the State Govt has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder. The State Govt. is requested to provide following additional information for further processing of the case:

- i) The State Govt may examine the justification for the proposal submitted by the user agency denying the violation and status of the forest land. It is also seen that the user agency has not submitted the undertaking for the CA & NPV. In these circumstances, State Govt may note that these undertakings are necessary for further processing.
- ii) Detail report on the violation of Forest (C) Act, 1980 committed by the user agency.
- iii) Action taken as per Ministry's letter No. 11-42/2017-FC dated 29.01.2018 para 3 B (iii) & (iv) may be submitted.
- iv) Status of the construction, whether completed or not.
- v) KML/Shape file for diversion area and CA area.
- vi) Whether Environment Clearance is required, if yes, the current status.
- vii) NPV is to be calculated as per revised rate dated 06.01.2022.
- viii) Status of FRA certificate.
- ix) GPS Coordinates of proposed forest land diversion & CA area.
- x) CA Scheme to be technically approved by Competent Authority.
- xi) The DFO, West Tripura mentioned in the specific recommendation about the presence of local wildlife including Jungle Cat, Leopard Cat, Small Indian Civet, Large Indian Civet, Common Palm Civet etc. Any action taken to safeguards if there is any impact due to the establishment on the wildlife.
- xii) Nearest distance for any Protected Area.
- xiii) The copy of the Hon'ble National Green Tribunal, Eastern Zone Bench, Kolkata disposing the matter may be furnished
