महोदय,

उपरोक्त विषय पर संदर्भित पत्र का आशय ग्रहण करते हुए मुझे आपको यह सूचित करने का निर्देश हुआ है कि इस कार्यालय के पत्र दिनांक 25.01.2023 द्वारा राज्य सरकार से कुछ सूचनायें चाही गई थी जिसका प्रतिउत्तर संदर्भित पत्र द्वारा प्रेषित किया गया है। प्रस्ताव में अधिक स्पष्टता हेतु इस कार्यालय द्वारा दिनांक 16.02.2026 को प्रस्ताव पर विस्तृत चर्चा करने हेतु बैठक आयोजित की गई। बैठक क कार्यवृत्त संलग्न कर प्रेषित किए जा रहे हैं। अतः आपसे अनुरोध है की प्रयोक्ता अभिकरण निम्नलिखित बिन्दुओं पर आवश्यक सूचनायें/ दस्तावेज प्रेषित करने का कष्ट करें, ताकि अग्रिम कार्यवाही सुनिश्चित की जा सके:-

1. The proposed diversion area shall be re-examined and re-assessed by the concerned DFO, as the total area involved is approximately 5.00 ha, whereas the proposed diversion area is 4.9962 ha.
2. Justification shall be provided as to whether the present proposal involves replication of facilities similar to those proposed at Golapar Sports University.
3. A component-wise break-up of the proposed Mini Stadium shall be submitted, indicating the area earmarked for hostels, playgrounds, and other infrastructure.

4. The Compensatory Afforestation (CA) scheme shall be prepared as per the revised/current wage rates.
5. Clarification shall be furnished as to whether the proposed diversion area falls within the Shiwalik Elephant Reserve or not.
6. A layout plan map on an A3 sheet shall be submitted by the User Agency.

**Minutes of Meeting dated -16.02.2026 (Mini Stadium proposal)**

वन (संरक्षण एवं संवर्धन) अधिनियम, 1980 तथा वन (संरक्षण एवं संवर्धन) नियम, 2023 के तहत उपरोक्त वन भूमि प्रत्यावर्तन से संबंधित प्रस्ताव पर चर्चा करने हेतु बैठक दिनांक 16 फरवरी, 2026 को पूर्वाह्न 11:00 बजे पर्यावरण, वन एवं जलवायु परिवर्तन मंत्रालय के क्षेत्रीय कार्यालय, देहरादून के सम्मेलन कक्ष में आयोजित की गई।

Following proposal was discussed in detail and accordingly, decision taken by the Regional Office, Dehradun is as under :-

**Diversion of 4.9962 ha of forest land for the construction of Shahid Mohan Nath Goswami Memorial Mini Stadium Lalkuan in favour of District Youth Welfare and PRD Officer within the jurisdiction of Tarai East, Haldwani Forest Division,**

**Nainital district of Uttarakhand. (Online Proposal No.- FP/UK/ROAD/21599/2016)****Discussion and Decision of REC:**

Regional Office, Dehradun considered the submissions made by the User Agency and the Divisional Forest Officer, Tarai East Forest Division through a PPT presentation. During the deliberations, the Regional Office, Dehradun raised concerns and sought clarification regarding whether any facilities different from those proposed at the approved Golapar Sports University are envisaged under the present proposal for the same purpose.

In this regard, it was observed that the distance between the proposed project site and the approved Golapar Sports University is approximately 15 km in same city. In view of the above, the following observations were made by the Regional Office, Dehradun, which are required to be submitted and duly justified by the User Agency:

1. The diversion area of the proposal shall be re-examined and reassessed by the DFO, as the total area involved is approximately 5.00 ha, whereas the proposed diversion area is 4.9962 ha.
2. Justification shall be provided as to whether the present proposal involves replication of facilities similar to those proposed at Golapar Sports University.
3. A component-wise break-up of the proposed Mini Stadium shall be submitted, indicating the area earmarked for hostels, playgrounds, and other infrastructure.
4. The Compensatory Afforestation (CA) scheme shall be prepared as per the revised wage rates.
5. Clarification shall be furnished as to whether the proposed diversion area falls within the Shiwalik Elephant Reserve or not.
