Kindly refer to the online proposal forwarded by the Government of Jammu & Kashmir on the above mentioned subject seeking prior approval of the Central Government for diversion of **0.315 ha** of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act. 1980.

- 2. After careful examination of the above mentioned proposal of the State Government the following information/clarifications are still required to be submitted for further processing:
 - (i) Total period of forest land proposed to be diverted is shown as NIL. Need to be uploaded.
 - (ii) Village wise break-up of forest land is shown as NIL. Need to be uploaded.
 - (iii) Undertaking to pay CA, NPV and Addl. NPV to be submitted.
 - (iv) Administrative approval of the project from competent authority to be submitted.
 - (v) Layout plan to be submitted.
 - (vi) Site suitability certificate for CA to be uploaded.
 - (vii) In DFO's site inspection report online proposal mentioned is erroneous. Revised site inspection report of DFO with corrected online number to be uploaded on web portal.
 - (viii) Detailed muck disposal plan with designated muck disposal sites on non-forest land to be submitted.
 - (ix) DSS/google earth shows that the area of KML file of project site is 0.62 instead of 0.315 ha. Revised KML file and DGPS map of the project site be provided/uploaded.
- 3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want to information.
