महोदय.

उपरोक्त विषयान्तर्गत सन्दर्भित पत्र का आशय ग्रहण करते हुए मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरांत निम्नानुसार कार्यवाही राज्य सरकार स्तर से अपेक्षित पाई गई है:—

- 1. In component wise breakup at B 2.4 state govt. may provide area details for each component in separate and reasons for repetition of components like tunnel, spillway, penstock etc.
- 2. The Power evacuation plan is not provided by the state govt. Hence, the state govt may provide the evacuation plan alongwith the separate T/L details in forest & non-forest area duly authenticated by competent authority.
- 3. State govt. may fill the scientific names of trees enumerated in online portal at para 4 (ii).
- 4. State govt. may submit the details of trees to be felled and not to be felled in separate. Further, the list of tree enumeration for the area proposed for dumping may also be provide in separate.
- 5. Comments on possibilities to change the sites marked for muck dumping from forest to non-forest area may also be submitted by the state govt. dully authenticated by DFO.
- 6. The Thaltikhod Stage-I HEP is overlapped with the Thaltukhod Stage-II HEP. Therefore, the comments on free flowing stretches of the Nallah between TRT of upstream and intake of downstream project may be provided by competent authority.
- 7. State Govt. may comment over quantity of E-flow based on discharge data of different seasons required to sustain fresh water ecosystem etc. downstream of diversion structures in view of above mentioned point no. 6
- 8. The state govt. may provide comments over river basin study of the catchment if any, bening carried out for river and if not, the State Govt. may provide comments on the future plan, if any in view of the carrying capacity of the river basin to generate power.
- 9. The 4.20 ha CA area of case no. FP/HP/HYD/43637 (Thaltukhod stage-II HEP) is overlapping with the area proposed for CA in this case. Therefore, need to be replaced with some other suitable area.
- 10. State Govt. may submit the Implementation Agreement and Techno-Economic Clearance to this office.

11. State Govt. may provide the complete Pdf file of the case through e-mail.
