Sir,

On verification of the compliance of the deficiencies submitted by you vide Letter under reference (3), the following shortcoming are not complied.

- As per Letter No.R&DM-GE (GL)-S-63/13-4822/CS dt.12.02.2015 of the Chief Secretary of Odisha addressed to all Collectors, necessary Certificate should be furnished by the Tahasildar as regards status of total land involved in the project (both Forest & Non-forest) as per Govt. record as on 25.10.1980.
- 2. The land schedule of proposed diversion area separately for Mining & Other ancillary activities and Safety Zone should be signed by the User Agency and authenticated by the Range Officer, Barsuan, Tehsildar, Lahunipara and DDM, Koira and to be enclosed to the diversion proposal.

Further, an area of 1.967 ha. of forest land has been proposed for conveyor passing through ML area in "the purpose wise break up of the total land required" (Page-5/DP). But, you have proposed an area of 1.993 ha. earmarked as proposed conveyor corridor in the Diversion Proposal of construction of Conveyor Corridor from Kurmitar Mines to new Railway Siding over 86.479 ha. The area do not tally each other.

Similarly, the table showing in the Proposed Land Use Plan (Plate No.V) "the purpose-wise break up of the total forest land required" needs to be rectified accordingly and the same should be authenticated by the Range Officer, Barsuan, Tehsildar, Lahunipara & DDM, Koira and enclosed to the DP.

Hence, you are requested to comply with the deficiencies and re-submit the Diversion Proposal immediately for taking further action at this end.

The Diversion Proposal is returned herewith.
