Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of 6.77 ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. The matter was discussed in the 4th REC and the following information/clarification are still required to be submitted, as per the decision of REC:

- (i) Accurate justification has to be provided as per the comments given by the committee.
- (ii) Employment generation should be given as per DPR and man days should also be added in the justification of employment generation.
- (iii) Total target CA plantation available as per the KML Files is 12.15 ha, whereas, the area required for the CA site is 13.54 ha, so one more CA patch has to be proposed. The provision of soil moisture conservation has to be incorporated and the CA plan needs to be corrected accordingly.
- (iv) Land suitability certificate of the proposal to be submitted as per modification of CA site.

3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want of information.
