The District Forest Officer, Nellore is informed that, as seen from the proposals uploaded by the DFO, Nellore in the Parivesh portal, it was noticed that the DFO, Nellore has not uploaded the approved CA Schemes of 1). Raising of 9.42 ha over the Non-Forest land identified in Sy.no.206 & 222 of Thummagunta Village and Sy.no.11 of Ekunampuram Village of C.S.Puram Mandal, Prakasam District and 2). Raising of 2.10ha., over the degraded CA area, measuring one and half times of the area of forest land under Safety Zone and furnished the Compensatory Afforestation Scheme. Further it was also noticed that in FORM-A (PART-II) the Progress of CA as on 16.03.2022 is mentioned as 10921.310 ha. in Forest land instead of 1092.310 ha. which is to be corrected.

In this regard, the District Forest Officer, Nellore is requested to rectify the above omissions and upload the same in the Parivesh portal and submit the report to this office for taking further course of action.
