Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of **12.052** ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. This proposal has been discussed for three times in the previous REC meetings of IRO Jammu, 3rd REC held on 12.01.2022 being the latest. Based on observations of the REC, queries were raised dtd 24.01.2022 and the compliance was received from your good office on 28.02.2022. Out of four queries raised by the REC, only one could be complied with vide your letter dtd 28.02.2022.

Hence, it is requested once again to send the following information, as per observations of REC, so that it is placed before REC for their consideration:

- (i) Uploading of correct KML file of muck dumping area, clearly indicating forest and non-forest patches alongwith accurate measurement.
- (ii) Self-speaking and well-illustrated area statement of the proposed diversion.
- (iii) Site inspection report highlighting area statement from the DFO after conducting dedicated site-specific inspection.

3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want of information.
