With reference to the subject and letter cited (i) above, I am directed to inform that the proposal mentioned above has been discussed in the 22nd REC meeting of the Integrated Regional Office. Guwahati held on 21st March, 2023 and the following information are to be submitted to this office as desired by REC for further processing of this proposal:-

- 1. The revised employment (permanent and temporary) likely to be generated out of the proposal.
- To recalculate the proposed muck dumping area in relevant to the proposed area.
- 3. The detail muck dumping plan mentioning the geo-coordinates of the muck dumping sites.
- To upload the kml/shape file of the corrected CA site identified in Kamle Reserved Forest under Hapoli Forest Division.
- The corrected kml/shape file of the proposed area and the muck dumping sites to be submitted.
- The technically approved and duly signed CA scheme of the identified alternate CA site as the submitted scheme has not been signed by APCCF & Nodal Officer(FCA), Govt of Arunachal Pradesh.

State Govt. is requested to furnish the above information along with the information sought by this office letter under reference above to this office at the earliest for further processing of the proposal.
