Sir,

With reference to the subject and letter cited above, I am to inform that the additional information submitted by the State Govt vide letter dated 23.01.2020 has been examined. On further examination of the information and the copy of Draft Notification for ESZ of Dehing – Patkai Wildlife Sanctuary, Assam dated 30.05.2019, the extent of the Eco-sensitive Zone ranges from Zero kilometer to 7.5 kilometers from the boundary of Wildlife Sanctuary. However, as per the information submitted by the State Govt vide letter dated 22.08.2019 at sl. no. 5, the proposed location is at 3.8 km distance from the boundary of the Dehing-Patkai WLS, Assam.

In this regard, the State Govt is requested to clarify as to whether the Draft Notification of ESZ in respect of Dehing – Patkai Wildlife Sanctuary, Assam dated 30.05.2019 has been finalized or not, and if so, whether the proposed diversion site falls within the ESZ or not. The State Govt may also clarify the status of Wildlife Clearance from standing committee of NBWL for 3 (three) number drilling wells in Deomali PEL area (which was submitted as online proposal No. FP/AS/MIN/1761/2017 dated 16<sup>th</sup> September, 2017).

The above information may be furnished at the earliest to this office for taking further necessary action.
