2. The following shortcomings are noticed which may be attended in all respect:-
1. The estimated cost of project as mentioned against the column A-1 (vii) is 34000 lacs, whereas, cost of the project in part-I of hard copy has been mentioned 34 crore, cost mentioned in online Part-I and hard copy of Part-I should match.
 2. The component wise detail as given in hard copy as well as in online Part-I is incomplete, the area of each component is required to be mentioned.
 3. The detail of employment likely to be generated as mentioned in hard copy is different from the detail mentioned in online Part-I.
 4. Document as placed at page number No. 66 is damaged / tore one, please place revised one.
 5. Against the column No. 13 (ii) of online Part-II the detail of CA scheme is not complete. Complete CA scheme is required to be uploaded.
 6. The calculation sheet of cost of trees has not been found placed in proposal folders.
 7. The muck management plan has not been found placed in proposal folders. In case muck to be generated will be used in the construction area then the detail of muck to be generated and to be used is required to be given alongwith the undertaking regarding use of such muck is required to be given.
 8. All uploaded and related documents in original/ authenticated copies are required to be uploaded in one PDF file against additional information detail of online Part-I.

You are, therefore, requested to make proper scrutiny of the proposal folders and submit the same after placing all requisite documents either in original or authenticated copies in it. However, the proposal folders as received with the memo are returned herewith for uploading in online portal.
