Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the above mentioned subject seeking prior approval of the Central Government for diversion of 2.2585 ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the above mentioned proposal of the State Government the following information/clarification are still required to be submitted:

- (i) Total period for which forest land is required is shown as NIL instead of 99 years.
- (ii) Village wise break-up of forest land is shown as NIL. Need to be uploaded correctly.
- (iii) Undertaking to pay CA, NPV and Addl. NPV to be submitted.
- (iv) The area for diversion in justification of proposal is 0.98 ha, while as the proposal has been submitted for 2.2585 ha. Clarification in difference in area to be given.
- (v) Permanent/Regular employment is shown as 125 persons. Need to clarify.
- (vi) In component wise break-up B-2.4 Non-forest land is shown as 6.1525 ha instead of 14.3615 ha. To be clarified.
- (vii) DSS/google earth shows that the area of KML file of project site is not matching with the proposed diverted area. Revised KML file of the project site be provided./uploaded.
- (viii) DSS/google earth that the total KML file of CA site is 1.99 ha out of it 0.7 hectare vacant space is available. Additional area of 3.8 hectare is required for target plantation.

3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want to information.
