Subject: Diversion of 7.3722 ha. of forest land in favour of Himachal Pradesh Power Corporation Ltd. for the Slongtong Karchhan HEP 450 MW due to enhancement in the existing capacity of HEP 402 to 450 MW and due to change in the river course during flood and usage of already diverted dumping site used by BRO , within the jurisdiction of Kinnaur Forest Division Distt. Kinnaur, HP. (online No. FP/HP/HYD/40611/2019).

2. The following shortcomings are still noticed which may be attended in all respect:-

1. The legal status of the forest land proposed for diversion has been mentioned as UPF in hard copy, but as per the point No. 2 in online legal status of forest land "Charagah Drakhtan" has been mentioned. Necessary correction is required to be made in this regard.
2. Against the point No. 11 (i) (a,b & c) no data has been mentioned further. It has been mentioned against point No. 12 that violation is still in progress, necessary comments in this regard is required to be given.
3. The bill of NPV and PNPV is not on current rates, revised bill of the same is required to be placed in proposal folders and online uploaded in online. Further, the maps of Penal CA is required to delete from online as well as hard copy.
4. Most of the documents placed at page No. 70 onward are photocopy whereas, original / authenticated copies are required to be placed in folders.
5. As per the detailed Report on violation placed at page No.52, violation over 0.5883 ha. forest land have been stated whereas, bill of PNPV for 1.1766 ha. has been prepared necessary correction in this regard is required to be made.
6. All uploaded and related documents in original/ authenticated copies are required to be uploaded in one PDF file against additional information detail of online Part-I.

You are, therefore, requested to make proper scrutiny of the proposal folders and submit the same after placing all requisite documents either in original or authenticated copies in it. However, the proposal folders as received with the memo are returned herewith for uploading in online portal.
