It is to inform that the Forest Range Officer, Proddatur in the reference 5<sup>th</sup> cited, has informed that a writ petition No.6412/2024 was filed in the Hon'ble High Court regarding cancelling the D.Form pattas in respect of the lands in Sy.Nos.2233/4, 2244/2, 2219/3, 2229/4, 2228/2, 2228/1, 2229/2, 2228/4, 2233/5, 2230/2, 2230/3, 2230/4, 2233/3, 2232/3, 2232/1, 2243/1, 2219/1, 2219/4, 2231/4, 2244/3, 2231/1, 2244/1, 2219/2, 2231/2, 2230/1, 2230/3, 2233/2, 2242/1, 2234/3, 2230/1, 2219/2, 2232/4, 2232/2, 2243/2, 2233/1, 2231/3 each measuring an extent of Ac.1.50 cents situated at Nandyalampeta village, Mydukur Mandal YSR Kadapa District. These lands are currently allotted as Compensatory Afforestation (CA) land for the project "Rehabilitation and upgradation of NH-167 B from Km 43/097 to 99/103 (Porumamilla to C.S.Puram via Seetharampuram)." The petitioners claim peaceful possession and enjoyment of the respective lands, and the revenue records are in their names as on today.

Further, the Forest Range Officer, Proddatur has informed that in the reference 4<sup>th</sup> cited, the Hon'ble High Court issued an order in Writ Petition No.6412/2024, IA .No.1 of 2024, stating "**in view of the above, there shall be an order of status quo obtaining as on today**".

Therefore, the Executive Engineer (R&B), NH Division, Kadapa is requested to kindly provide another Compensatory Afforestation land which is not having legal issues and encroachments etc., for further processing the proposals at the earliest.
