Subject: Proposed forest land (Protected Forest) diversion for 765 kV double circuit transmission line Orai Aligarh transmission line involving 1.0082 ha in Aligarh District with felling of 11 trees and 0.6595 ha in Hathras District with felling of 46 trees & 280 poles, total 1.6677 ha of trees with felling of 57 trees and 280 poles-reg.

Sir,

In reference to your above mentioned letter where approval for above referred forest land diversion proposal was sought; I have been directed to convey following shortcomings of the proposal for necessary rectification:

- As per GIS DSS analysis following points regarding proposed forest land for diversion and proposed compensatory afforestation:
 - Kml files of alternated routes are not provided.
 - The SOI toposheet of proposed land to be diverted as well as CA land has not been submitted.
 - Proposed CA area shows good vegetation therefore site suitability for compensatory afforestation needs a relook.
- Details of employment generated in E of part I is not consistent with details provided in short narrative of the project.
- Land schedule shall be revised keeping perpendicular distance as approved RoW which is 67 mts in this case.
- As per part II of the proposal there exists violation of FCA 1980, a self contained duly providing details of violation, causes, extent etc need submission from the concerned DFO along with details of action initiated.
- Site inspection report of DFO Hathras does not indicate legal status of forest land.
