I am directed to refer to State Government's letter No. FEE 202 FLL 2025 (e) dated 30.12.2025 seeking prior approval of the Central Government in accordance with Section '2(1)' of Van (Sanrakshan Evam Samvardhan) Adhiniyam 1980 wrt above subject proposal. After analyzing the proposal the following are observed:-

- i. As per the satellite imagery, there is already a road to access the Patta land which is proposed for diversion. Therefore, the State Government is requested to furnish the status of the road i.e. whether it is a pre 1980 road or otherwise and if the road is being used in violation to Van (Sanrakshan Evam Samvardhan) Adhiniyam 1980, the proposal needs to be submitted to MoEF&CC, New Delhi as per subrule 2(v) of rule 10 of VSES Rule 2023.
- ii. State Government is requested to justify need for a new cart which involves cutting of 28 tree species, when already a road is existing.

In view of the above, the State Government is requested to submit the above mentioned information/clarification for further consideration of the proposal.
