The Executive Engineer, PR Division, Bhadrachalam, Bhadradi Kothaugdem District is informed that vide reference 4th cited proposals (7 sets) for diversion of forest land of **2.334 Ha** of forest land in Bhadradi Kothaugdem District for widening and upgradation of the existing road from **Bodanalli to Kurkattapadu** of Bhadrachalam Division in favour of EE, PR Department, Bhadrachalam were forwarded to the Forest Divisional Officer, Bhadrachalam/District Forest Officer, Bhadradi Kothaugdem/CCF/CF, Kothaugdem for processing of the same.

The CCF/CF, Kothaugdem vide reference 5th cited has reported that the District Forest Officer, Bhadradi Kothaugdem has examined the proposal and after inspecting the proposed area on 30-8-2019 and stated that the proposed road is Korkattapadu Village, which is illegally established by the Gothikoyas in Pedamidisileru RF the total numbers of families residing in the village are (56) Nos. and population is (380) Nos. Gothikoyas tribes area not recognized in Telangana State. Further, it is stated that the laying of Road will prevent the Department to evict them in future and encourage them to settle permanently and further destruction is apprehended.

In view of the above and in the circumstances reported by the CCF/CF, Kothaugdem above, the proposals submitted vide reference 3rd cited are hereby rejected.
