With reference to the subject and letter cited above, I am directed to inform that this office observed that the source of the oil is from "exploratory cum appraisal well" KSAG which was earlier mentioned as "appraisal well" and drilled from the exploratory well site "KSAC" without permission of land use change from competent authority under F(C)Act, 1980. State Govt is therefore requested to provide the status of the application for land use change for drilling additional "exploratory cum appraisal well KSAG" from the exploratory well site of "KSAC" and action taken if any, by the State Govt on such irregularity against the responsible person as per F(C)Act, 1980 to this office for further processing of this proposal.
