Sub: Diversion of 5.475 Ha. of forest land for construction of 132/33 KV Transmission Line from Grid Sub-station Boudh to proposed 220/132/33 KV Grid Sub-station at Kiakata- Submission of hard copies of forest diversion project proposal-reg.

Sir,

In inviting a reference to the above cited letter on the captioned subject, it is to inform you that, the aforesaid forest diversion proposal has been submitted through PARIVESH web portal on dt. 14.02.2022 and the said diversion proposal hard copies submitted to this office on dt.15.03.2022 which is one month later. It defeats the objective of time bound scrutiny and provides very less time for scrutiny. On scrutiny of the said diversion proposal the following observations are made.

1. The tree enumeration list is not submitted.
2. All the maps are not authenticated from the concerned officials.
3. Demand letter of the project authority is not available.
4. Cost benefit analysis (Annexure-4) is not available.
5. Details of non- forest land / Degraded forest land identified for Compensatory Afforestation is not available.
6. The Compensatory Afforestation scheme is not available.
7. The location map of degraded forest area identified for raising Compensatory Afforestation is not available.
8. No objection certificate from the Gram sabha was not submitted.
9. Hal and Sabik certificate from the concerned authority is not available.
10. Abstract of land schedule is not submitted.

Hence, the previously submitted Diversion Proposals (in three sets) are returned herewith for necessary compliance at your level and re-submission of corrected Diversion Proposals complete in each respect to this office as per the check list of Forest Conservation Act, 1980 for taking further action and onward transmission to higher quarters.
