Regarding exemption from the purview of Van (Sanrakshan Evam Samvardhan) Adhiniyam 1980, as per provision given under clause (b) of Sub-section-1A of the Adhiniyam, r/w Consolidated Guidelines and Clarifications dt.29.12.2023 issued by MoEF & CC, Govt. of India, with respect to 23.80 ha mining lease area of Kalarangiatta Chromite Mines of M/s Ferro Alloys Corporation Limited (FACOR).

Sir.

With reference to the letter cited above on the captioned subject, it is to inform you that, you have requested for allowing mining operation in Kalarangiatta Chromite Mines as per Forest Conservation Amendment Act, 2023 called as Van (Samrakshan Evam Samvardhan) Adhiniyam (Amendment-2023) and applicability of Provision available for Section-1(A) thereof.

But, in the mean-time on dt.19.02.2024 the Hon'ble Supreme Court has passed an interim order directing that, States and Union Territories must act as per the definition of "forest" laid down in the 1996 judgment in T.N Godavarman Thirumalpad v. Union of India while the process of identifying land recorded as forests in Govt. records is going on as per the 2023 amendment to Forest (Conservation) Act.

Considering the above this office is unable process your request till disposal of this case by the Hon'ble Supreme Court of India.
