Proposal for diversion of 18.028 ha of forest land for construction and commissioning Sub: of 132 KV Transmission line from Agia GSS to Goalpara TSS in Rakhayashini PRF under Goalpara Division in favour of Central Organization for Railway Electrification, Guwahati.

Sir,

Please refer the State Govt letter on the subject mentioned above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. I am to inform that the proposal referred above has been examined in this office in the light of Forest (Conservation) Act, 1980 and rules/guidelines framed thereunder and the following clarification and lacking information/documents is to be submitted:-

(1) The original or colour scan SoI map indicating the 3-alternate route examination (route I, II and III) with proper legend.

(2) State Govt. to submit the signed Part V form mentioning specific recommended

proposed area as it is submitted unsigned.

(3) The 3-alternate route examination (I, II & III) along with the justification for choosing the proposed alignment mentioning ecological parameters i.e., forest cover, density, forest type, habitation etc.

(4) The SoI map indicating the proposed area has not been countersigned by the concerned DFO, hence the submitted SoI map is returned herewith and State Govt

to resubmit the countersigned map.

(5) The HEC mitigation and wildlife conservation plan approved by CWLW as recommended by the Nodal Officer (FCA), Govt of Assam.

(6) The Cost Benefit Analysis of the proposed area.

(7) The aerial distance of the proposed area from the nearest Protected Area/Wildlife Sanctuary/National Park.

(8) The technically approved and duly signed dwarf species plantation scheme.

(9) The site suitability certificate of the CA area proposed.

- (10) State Govt to clarify whether any scheduled-I species, mammals, birds, other wildlife is present in the proposed alignment, if yes, site inspection report from CWLW along with appropriate necessary mitigation measures for the possible impact on the wildlife due to the proposed high-tension line and wildlife mitigation plan is to be submitted.
- (11) The current status of FRAct, 1980 of this instant proposal.
- (12) The undertaking certificate by the user agency for payment of cost of tree extraction/removal by the user agency.

The DSS report on the proposed area and the CA site is awaited from FSI, Dehradun and the same shall be communicated, if required.

State Govt. is requested to kindly furnish the above requisite information to this office for further processing of this proposal.
