Proposal for diversion of 0.29 Ha. Of Forest Land for Construction of 132KV Transmission Line from 132/33KV Grid S/s, Boudh to proposed 220/132/33 KV Grid S/s, Kiakata by OPTCL.

Sir,

With reference to the above cited letter on the captioned subject, you have submitted the hard copies of the aforesaid forest diversion project proposal to this office vide letter no. under reference. During scrutiny of the same following discrepancies have been found.

- 1. The index has not been attached in DP.
- 2. Area of the forest land proposed for diversion mentioned in Part-I village wise breakup in Check List No. 7 is mismatched.
- 3. Authenticated document that the UA has applied to competent authority for settlement of rights under FRA has not been submitted.
- 4. Species wise (Scientific Name) and Girth-class wise enumeration list of trees standing in the forest and non-forest land involved in the project have not been submitted separately.
- 5. Land Schedule of Revenue Forest Land has not been vetted by concerned Range Officer and concerned Tahsildar.
- 6. Undertaking for payment of cost of Penal CA, Addl. CA and SSWLCP have not been submitted.
- 7. Technical sanctioned copy of the project (Annexure II) as annexed in Part I has not been submitted.
- 8. DGPS Maps of proposed Diversion Area vetted by ORSAC have not been authenticated by the concerned Forest and Revenue Officials.

- 9. An undertaking for submission of Stage-I compliance within one year of the Stage-I approval / before expiry of working permission has not been submitted.
- 10. The cadastral map as annexed in Part I as Plate VI XIII have not been submitted.
- 11. Guidelines of MoEF & CC, GoI regarding Cost Benefit Analysis annexed as Anexxure IV has not been submitted.

Hence, the above forest diversion project proposal is returned herewith for necessary compliance of the observations raised by the undersigned and resubmission at an early date for further processing of forest diversion project proposal at this end.
