विषय: Diversion of 3.9654 (instead of 5.5334 ha) of forest land in favour of HPPWD for the construction of link road Khal Tibba (Kms 0/00 to km 7/00) within the jurisdiction of Bilaspur Forest Division, Distt. Bilaspur, Himachal Pradesh. (Online Proposal No. FP/HP/Road/20681/2016).

महोदय,

उपरोक्त विषयक संदर्भित पत्र का आशय ग्रहण करते हुए सूचित करना है कि अनुपालना रिपोर्ट में निम्नलिखित कमियां पाई गई हैं :-

1. The village wise breakup needs to be filled in Part-I, Para-B.2.3 showing detail of forest and non- forest land.
2. The State Government may clarify whether area selected for CA is a waste land under Himachal Pradesh Government notification 1952.
3. The revised NPV and Penal NPV calculation sheet in consonance with MoEF&CC order dated 06.01.2022 may be provided in PARIVESH portal.
4. In FRA, Site Inspection of DFO, recommendation of DFO & CF, area is mentioned as 5.5334 ha. However, area in the extant proposal revised to 3.9654 ha. Therefore, in view of this revised documents be submitted/uploaded to this office.
5. The dumping sites are proposed in forest land. Therefore, State Government may explore suitable non-forest/ private land for muck dumping.



6. The enumeration of trees standing in dumping sites has been provided for 09 dumping sites only. Therefore, separate list of trees standing in each dumping sites, if dumping sites are proposed on forest land.
7. As per Muck Management Plan, area of the each dumping site is 400m<sup>2</sup>. However, this area is not matching with the area mentioned in component-wise breakup. Therefore, same may be clarified and rectified accordingly.
8. The State Government may provide project approval document issued by competent authority.
