or

b) As prescribed by this Ministry in its letter No. 11-09/98-FC (pt), dated 28th October, 2014, in case of plantations which were notified as 'forest', a certificate from the concerned District collector to the effect that the forest land proposed to be diverted is plantation which was notified as "forest' less than 75 years prior to the 13th day of December 2005 and is located in villages having no recorded population of Scheduled Tribes as per the census-2001 and the census 2011, be issued and aubmitted to meet requirements of clause (a), read with clause (d) and clause (g) in second para of this ministry's letter issued vide F.No. 11-9/1998-FC(pt), dated 3rd August. 2009.
