Sub Forest (Conservation) Act, 1980 – Proposal for diversion of 0.27 ha of forest land in Thiruthuraiyur RF of Cuddalore Forest Division for construction of BT approach road, cremation shed, providing water supply and street lights to burial ground of Thiruthuraiyur village in Cuddalore District in favour of the Block Development Officer (BP), Panchayat Union, Annagramam, Cuddalore District – Proposal forwarded - Regarding.

Attention of the Conservator of Forests and District Forest Officer are invited to the references cited.

On-line proposal for diversion of 0.27 ha of forest land in Thiruthuraiyur RF of Cuddalore Forest Division for construction of BT approach road, cremation shed, providing water supply and street lights to burial ground of Thiruthuraiyur village in Cuddalore District in favour of the Block Development Officer (BP), Panchayat Union, Annagramam, Cuddalore District has been forwarded and hard copy of the proposal in duplicate has been furnished in the above references 4<sup>th</sup> and 5<sup>th</sup> cited.

Following shortcomings have been noticed.



i) Instructions had been issued to the District Forest Officer, Cuddalore Division in PCCF letter TS3/57873/2019, dated 16.10.2020, to furnish the proposal in triplicate copy. However proposal has been furnished in duplicate copy.

ii) In the online application, the user agency has uploaded 16 documents under additional information details section. However the user agency has furnished signed hard copy of the application with 13 documents only.

iii) In the copy of Thiruthuraiyur Reserve Forest notification attached in the proposal, two rights of burial ground with an extent of one acre and 0.50 acres of land with approach path @ 30 links (6.00m) wide had been allowed for Thiruthuraiyur village.

The user agency has proposed to construct BT approach road @ 5m width, cremation shed, providing water supply and street lights to burial ground allowed for one acre extent. The District Forest Officer has reported that right of way has been admitted as per Thiruthuraiyur RF Notification..

Location of one acre extent burial ground allowed in the settlement process along with the improvement facilities proposed has not been marked in the Survey of India topo sheet.


