

Please refer to your letters mentioned above regarding submission of details of the alternate land in respect of diversion of 1.592 ha of Forest land at Jampore for the work, 'Construction of Protection wall with Jampore ghat for Extension of Jampore Sea front upto Varliwad School at Jampore, Moti Daman on Forest land in Daman District'. In this regard, the survey and demarcation of the total land area of 26.12 Ha {PTS-44/1(P),44/1-F,100/1(P),102/1,104/8} allotted to Fudam Bird Sanctuary was done recently as communicated vide letter no. 6-16-2022-23/CTS/DIU/LND/244 dt. 23.02.2023 by the Enquiry Officer, City Survey, Diu.

Now, after the survey and demarcation of the said land, it is observed that the alternate land (20°43'1.44⁰N-70°57'45.23⁰E, 20°43'1.73⁰N-70°57'51.92⁰E, 20°42'58.84⁰N-70°57'51.79⁰E, 20°42'58.67⁰N -70°57'45.72⁰E) proposed by you for Compensatory afforestation in respect of the said project falls outside the boundary limits of the land allotted (26.12 ha).

As such, it is requested to provide the details (including uploading of KML file) of the alternate land with changed location within the 26.12 Ha land allotted in consultation with the undersigned.
