Observations:

(i) Justification for locating the project in forest land not authenticated by DFO.

Action required: State Government may authenticate the justification for locating project in forest land and upload it at para- D part-I. . Original hard copy of the same may also be provided.

(ii) The cost benefit analysis provided in hard copy and uplaoded at para 'G' Part-I is incomplete and not in prescribed format.

Action Required: The State Govt. may submit and uploaded C/B analysis in prescribed format of MoEF & CC letter dated 01.08.2017 with all parameters quantified in monetary terms.

(iii) As per DSS analysis of the CA area complete 12.00 ha area falls in Moderately Dense Forest (MDF).

Action required: State Government may provide plantation scheme of 12000 trees in lieu of this MDF area, @ of 1000 trees per ha. with detail of the area selected for plantation as per prescription of working plan.

(iv) Employment likely to be generated during the construction of project at para E Part-I seems to be incorrect.

Action required: State Government may fill the correct details at para E Part-I regarding employment generation.

(v) All the documents uploaded online as addl. document in Part-I is though signed but name and stamp of the person signing the document is not found.

Action required: State Government may provide revised documents after getting it properly signed by the concerned authority.

(vi) Muck disposal is proposed in Reserve forest and only photographs are attached in muck management plan.

Action required: State Government may review the review the muck disposal as per the guidelines and submit Muck management plan showing total muck likely to be generated, muck to be utilized in the project and muck likely to be disposed in the dumping sites which also required to be uploaded online as additional document. (vii) Density mentioned in Part-II is 0.4 for 1038 trees in 5.964 ha area, which should be higher than this and in NPV calculation sheet it is mentioned as 0.6.

Action required: State Govt. may clarify this discrepancy and do the necessary corrections.

(viii) SIR at para-15 Part-II is not clear and legible.

Action required: State Govt. may upload the clear and legible scanned copy of SIR at para-15 Part-II online.

(ix) Recommendation of DFO at para-16 Part-II is not clear and legible.

Action required: State Govt. may upload the clear and legible scanned copy of Recommendation of DFO at para-15 Part-II online.

(x) FRA uploaded online is of dt. 22/04/2016 but in hard copy it is for 07/04/2016 and on format for non-linear project.

Action required: State Government may submit the clarification in this regard.

(xi) Undertaking by User Agency to bear the cost of CA, NPV and reclamation cost is not found uploaded.

Action required: State Government may upload the Undertaking by User Agency to bear the cost of CA, NPV and reclamation cost as additional document in Part-I.
