On verification of the Section-2 proposals under FC Act, 1980 for the proposals mentioned in the subject matter the following omissions/ short comings are noticed. The Divisional Forest Officer, Nellore therefore instructed to rectify the omissions/ short comings as noticed and resubmit the Section-2 proposals for further processing the omissions noticed are as follows:

- 1. DGPS survey for doubled the CA land in degraded RF area over an extent of 3.474 or 4.00 ha has not been done by the user agency.
- 2. DGPS original survey map for proposed diverted area has not furnished.
- 3. DGPS survey map in topo sheet not signed by the user agency.
- 4. Date of DGPS survey conducted in the presence of user agency and forest officials is not furnished.
- 5. The Form-I (for linear projects) to be obtained from Dist.Collector, Nellore for 1.737 ha instead of 3.658 ha and locations mentioned should also be rectified (RoFR Act, 2006).
- 6. Original documents to be furnished for check list page no.1 to 19 and 25 as they are intended to submit to GOI for getting approval.

7. Enumeration of tree growth in the proforma given duly furnishing the volume of trees felled and cases booked and action taken for violation of FC Act, 1980 as stated by the Divisional Forest Officer, Nellore in his field inspection against the user agency.

The proposals submitted by the Divisional Forest Officer in 5 sets on subject matter is herewith returned for supplying the omissions.
