ON LINE PROPOSAL No: FP/UP/ROAD/22374/2017

Subject: Proposed forest land diversion of protected forest for strengthening and widening of NH 91(Aligarh to Kanpur section) from chainage 186.000 km to 229.000 km having extent 65.495 ha with removal of 4940 trees & 858 plants total 5,798 numbers-reg.

Ref: Letter no. P-15/14-2-2018-800(12)/2018 dated 6th February 2018

Sir.

In reference to your above mentioned letter where approval for above referred forest land diversion proposal was sought; I have been directed to convey following shortcomings of the proposal for necessary rectification:

- Three proposals FP/UP/ROAD/24596/2017, FP/UP/ROAD/23288/2016 and FP/UP/ROAD/22374/2016 appears to be part of widening of National Highway 91 and total extent of diversion is more than 100 ha which requires site inspection from Regional Office, MoEF&CC as per guidelines of FCA 1980.
- 2) There exists a rounding off error in totalling extent of village wise forest area at B 2.3 in part I.
- 3) As per GIS DSS analysis of proposed forest land for diversion, following issues need rectification:
 - a) The area of proposed forest diversion is 56.52 ha whereas the proposal is submitted for 65.495 ha. Either kml files are erroneous or calculation of area is incorrect.
 - b) Overlay of kml files of proposed forest land diversion on Google Earth image shows lateral shift.
- 4) Benefit Cost analysis of the proposal is not as per latest guidelines of MoEF&CC. This needs revision.
- 5) In land schedule prepared for forest land calculation, one additional column for balance available width of PF after deducting for proposed width for diversion shall be provided.
- 6) As per GIS DSS analysis of proposed compensatory afforestation, following issues need rectification:
 - a) Uploaded kml files for CA at 13(i)-3&4 are not accessible and showing error.
 - b) The extent of CA proposed suitable for plantation is 128 ha only. One 4 ha patch is a water body. An additional patch of extent more than 3 ha is needed to meet the shortfall.
- 7) Site Inspection Report of DFO mentions translocation of 201 number of Ficus trees.
 - a) A detailed estimate along with suitable location for translocation shall be submitted by the concerned division.
 - b) Undertaking from user agency is needed to fund the proposal.
 - c) State Government shall specifically recommend this additional proposal.

Therefore, the proposal is hereby placed under EDS category for rectification/revision of the same as per the observations made above in point wise manner. It is also advised that reply shall be

provided at the earliest so that the proposal may be discussed in next REC. I have also been directed to ask State Government to seek explanation of concerned Forest Officers for scrutinizing the proposal in a casual manner.
