उपरोक्त सन्दर्भित पत्र का आशय ग्रहण करते हुए मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरांत निम्निलिखित कमियां पाई गयी है:

This is a case of violation also listed in the 2183 cases of violation submitted to the Hon'ble High court of HP

- 1. The broken area is 1.05 ha while in online Part-II Para 11 the broken area is said to be 1.21. **Action Required:**—State Govt. may correct the broken area in online part-II.
- 2. The proposal involved violation of FCA, 1980 for which as per guideline dated 29.01.2018, penal NPV is required.

<u>Action Required</u>:- State Govt. may submit the undertaking & calculation for penal NPV as per guideline dated 29.01.2018.

- The working plan prescription at para 5 of Part-II online seems to be incorrect.
 Action Required: State Govt. may rectify the working plan prescription in online at para 5 of Part-II.
- 4. There is possibility of erosion during said construction as per the information provided by DFO in Part-II online.

Action Required:- State Govt. may submit the details for mitigation of erosion and the availability of fund for the purposes.

- The area proposed for diversion is 7.5 km away from nearest Wild Life Sanctuary.
 <u>Action Required:</u> The State Govt. may submit the comments of Chief Wild Life Warden in this regard.
- 6. The employment details provided at para E (ii) appears to be incorrect.

Action Required:- The State Govt. may review again in such cases it should be nil and correct the details at para E (ii) online.
