Sub: Proposal for diversion of 10.155 ha of forest land for widening of NH-57 from Bolangir to Sonapur under Subarnapur Forest Division by Executive Engineer, NH Division, Bolangir.

Ref: Memo No.3663 dated.29.12.2016 of RCCF, Bhawanipatna Circle.

With reference to the above correspondence on the captioned subject, it is to inform you that during scrutiny of the Forest Diversion Proposal for widening of NH-57 from Bolangir to Sonapur the following deficiencies are noticed.

1. Part-II (Online copy) enclosed has not been signed by you and Part-II (old format) duly filled in has not been furnished.
2. Your site inspection report is not in proper format.
3. The species class-wise and girth class-wise abstract of trees enumerated from the forest land applied for diversion and non-forest land duly signed by you has not been furnished in the DP.
4. The extent of non-forest land involved in the entire projet is not clear. In Form-A, it is mentioned to be 8.81 ha whereas as per the land schedule enclosed the area comes to be 7.927 ha.
5. Certificate regarding status of non-forest land as on 25.10.1980 from the Tahsildar concerned has not been furnished.
6. The applied area has not been properly delineated in distinct colour on the Topo Map with index and also has not been signed by you.
7. The linear diagram with crossing section of the road has not been enclosed in the DP.
8. The DGPS Map has not been authenticated by you and the User Agency. Further, one original copy of the same has to be furnished.
9. The KML File/ Shape File of the forest land proposed for diversion in CD form in triplicate has not been appended to the DP.

10. The Compensatory Afforestation Scheme has not been detailed. Further, the provision of maintenance has to be kept for 10 years.
11. The Diversion Proposal has to be ring filed with page numbering, so that Part-IV, V and other documents can be incorporated.

In view of the above deficiencies, the diversion proposal in quadruplicate is returned herewith for necessary compliance and immediate resubmission for further action at this end.
