Sir,

With subject and reference cited above, I am directed to inform that the State Govt. vide letter under reference has submitted the above mentioned proposal to this office seeking prior approval of Central Government under Section-2 of Forest (Conservation) Act, 1980. On examination proposal following was observed.

- a. The DFO, Baripada has reported that the area proposed for diversion i.e. 0.890 ha is already in use since 19.11.2003. The Hal Kissam of the area is found to be Patit (Non-forest) but, the Kissam of land as on 25.10.1980 is Jungle-I/II/Forest. The details of action take report on violation may be furnished.
- b. A Site Selection Committee was held on 05.06.2002 in the office of Collector and District Magistrate, Mayurbhanj for selection of site for different projects including Mayurbhanj College of Accountancy and Management. However, who has allotted the instant proposed land has not been reported by the State Govt.

It is therefore requested to submit the compliance of the above observation to this office for further processing of the proposal.
