With subject and reference cited above, I am directed to inform that the State Govt. vide letter under reference has submitted the above mentioned proposal to this office seeking prior approval of Central Government under Section-2 of Forest (Conservation) Act, 1980. 1. The DFO, Cuttack has reported that the applicant has already constructed concrete structure within the proposed forest area over 0.104 ha out of 0.433 ha of Sabik Forest land involved in the proposal in violation of FC Act, 1980. Hence, detail action taken report on violation may be submitted.
