A copy of the references cited along with enclosures is communicated herewith for information and necessary action.

The District Forest Officers, Chittoor and Sri Satya Sai are requested to go through the references cited and furnish the detailed report and specific remarks for the following points.

- i. Out of 41 projects, 13 number of CA blocks were notified as Protected/Reserved Forests. Remaining 28 blocks are under process for notification. In this regard, the DFO concerned is required to submit the notification of the remaining 28 blocks.
The DFO Chittoor and Sri Satya Sai verify the Projects in your Division and Status of notification of Blocks and submit detailed report in this matter.
- ii. DFO, Chittoor shall provide details of action taken for violation of Adhinyam, 1980 and for non-compliance of the stipulated condition along with action plan for reclamation of mines.
- iii. Further, there is another proposal (M/s Vasista Mines) adjacent to the instant proposal and as the sub-committee has also recommended that since the area and site is same, the specific recommendation made by the sub-committee may also be considered while processing the proposal. Accordingly, the instant proposal and proposal for M/s Vasista Mines may be taken together. In this regard, the State Government/ Regional Office shall submit both the proposals with recommendation for a holistic decision in this matter so the conditions to be stipulated may be mutatis mutandis in the two cases.
- iv. The above information should reach this office within a week days for onward submission to PCCF&HoFF, A.P., Mangalagiri.
