Subject: Proposed forest land diversion of protected forest for strengthening and widening of NH 91(Kalyanpur to Navinganj section) from chainage 229.000 km to 289.000 km having extent 97.896 ha with removal of 11,377 trees-reg. Ref:

Sir.

In reference to your above mentioned letter where approval for above referred forest land diversion proposal was sought; I have been directed to convey following shortcomings of the proposal for necessary rectification:

- 1) Signature of person making application on behalf of the User Agency has not been
- FP/UP/ROAD/24596/2017, FP/UP/ROAD/23288/2016 and proposals FP/UP/ROAD/22374/2016 appears to be part of widening of National Highway 91 and total extent of diversion is more than 100 ha which requires site inspection from Regional
- 3) As per GIS DSS analysis of proposed forest land for diversion and propose compensatory afforestation, following issues need rectification:
 - Some portion of propose forest land diversion overlaps with existing road.
 - Overlay of kml files of proposed Compensatory afforestation shows presence of structures. This issue needs rectification and explanation regarding suitability of site.
- 4) Benefit Cost analysis of the proposal is not as per latest guidelines of MoEF&CC. This
- 5) The requisite documents for FRA 2006 have not been uploaded with the proposal. It has been mentioned that the same has been applied for.
- Forest Gazette notification uploaded with the proposal is without date of notification and
- 7) The land schedule showing chainage wise area calculation does not provide for balance of PF available on both side and reasons for varying width requirement.
- 8) NPV calculation of forest land proposed for diversion is based on incorrect rates.
- The site inspection report of the concerned Conservator of Forest is required on
- 10) Enumeration list with hard copy and online enumeration list shows variance of 4 trees or poles. This issue needs rectification as per ground condition.



Therefore, the proposal is hereby placed under EDS category for rectification/revision of the same as per the observations made above in point wise manner. It is also advised that reply shall be provided at the earliest so that the proposal may be discussed in next REC.
