**विषय:** Diversion of 3.7381 ha. in (2.2099 ha. of Ambala, 1.0222 ha. Of Yamunanagar, 0.029 ha. of Kurukshetra 0.477 ha. of Karnal) of Forest land in favour of Project Director National Highways Authority of India Ambala for Construction of 6-lans access-controlled Highway from Shamli to Ambala along Mohri-Kesri road K.M 12-13 L/R/Sidi, Jagadhari Ambala Road Km. 41-42 Lt/Side Mithipur to Sambhalka Road L&R Side, Hamidpur Bund 0'Tail R/L Side, Adhoya to Akalgarh Road r-2 WL Side, Alawapur-Foxa Line Road R/L Side in state of Haryana and Uttar Pradesh and Punjab under Forest Division & District Ambala (Online Proposal No.FP/HR/Road/153630/2022)-regarding

**सन्दर्भ:** i). अतिरिक्त मुख्य सचिव (वन एवं वन्यप्राणी), हरियाणा सरकार के पत्र संख्या 798-व-3-2023/1684 दिनांक 13.03.2023. महोदय,

मुझे आपका ध्यान उपर्युक्त विषय से संदर्भांकित पत्र की ओर दिलाने का निर्देश हुआ है, जिसमें वन (संरक्षण) अधिनियम, 1980 की धारा- 2 के अनुसार गैर वानिकी उद्देश्य के लिए 3.7381 हेक्टेयर वन भूमि की मांग की गई है।

2. प्रस्ताव से सम्बंधित निम्नलिखित जानकारी भेजने का कष्ट करे: -

- In part-I, B.2.3 village wise breakup of non-forest land is not uploaded for all villages due to this non forest land calculated as 218.4091 instead of 354.4619 as uploaded under B-2.4 and it needs to be corrected.
- In the area calculation sheet, uploaded in part-I at Sn. 01 & 12, area calculation for yamunanagar is given as 0.939 ha, instead of 1.0222 ha and needs to be correctly uploaded.
- As the proposed road passes through railway lines/canals/streams, NOC from Irrigation & Railway OR undertaking to submit NOC from Railway and Irrigation Department before S-I needs to be submitted.
- CA Scheme: In Ambala Division, the CA scheme needs to be prepared for double of the area to be diverted ie 4.418 ha instead of 5400 plants and the barbed wire fencing cost needs to be rationalized for the perimeter of polygon proposed as per uploaded KML. The site-specific proposed activities need to be elaborated under SMC works instead of flat 30% of total CA. Hence, incorporating these changes, revised CA scheme needs to be uploaded.
- Under Karnal Division and Yamuna Nagar Division, the site specific proposed activities need to be elaborated under SMC works instead of flat 30% of total CA. Hence, revised CA scheme needs to be uploaded for these two divisions also.
- Approval of the competent authority for the instant project is not submitted.
- Linear plan clearly showing the component-wise and dimension-wise forest as well as non-forest area requirement in distinct colour has not been submitted. Hence, linear plan clearly showing the component-wise and dimension-wise forest as well as non-forest area requirement in distinct colour duly counter signed by DFO concerned needs to be submitted.
- Under Yamuna Nagar Division, approx. 0.8 ha. area is available for plantation & i.e., not sufficient to plant 2394 plants. Hence, the CA site needs to be revised to accommodate the target plantation.
