Subject: Diversion of 0.48 ha of forest land in Vikarabad Division for widening of (2) lane with paved shoulders and re-alignment from km 59.500 to 132.033 of Manneguda-Ravulapalli Section of National Highway -163(erstwhile SH-4) of which forest reach begins from km 96/130 to 96/330 (191.31 m length and 25.10 mtr width) under EPC mode under NH(O) in favour of Executive Engineer, R&B, NH Division , Hyderabad-reg.

Sir,

Please refer to the subject and reference cited above and I am hereby directed to request to furnish the following additional information / documents at the earliest for further processing of the proposal;


- In part I of the proposal, UA has reported that 0.48 ha of forest area proposed for diversion is within the right of way (RoW). However, as per the KML file uploaded in the online application, the width calculated from older road to the end of proposed road is upto a maximum of 59 mtrs. Hence actual width of RoW of the existing road needs to be furnished.
- As per the kml file uploaded, the existing road is approximately 4 mtrs, however, under subject proposal, the road width proposed is 25.1 mtrs. Hence, justification for this much of width may be furnished;
- Both sides of the road as per the new alignment proposed for diversion is not touching the already existing road. Clarification as to how the newly proposed alignment is going to be juxtaposed may be furnished;


