

Madam,

With subject and reference cited above, I am directed to inform that the present proposal involves violation of FC Act, 1980 and State Govt. has submitted proposal for ex-post facto approval. The proposal was discussed in the REC meeting held on 15.09.2022 and as per Ministry's letter No.FC-7/43/2020-FC dated 22.03.2022, the proposal file was submitted to the Ministry on 08.02.2023 for consideration. The Ministry has returned the file with the following observation:

- 1) Whether the revenue records had any entries of 'forests' in 2001 or not?
- 2) Whether the structures on the land in question have been constructed before 2015 or after 2015?

Further, this office vide letter dated 23.09.2022 has requested the State Govt. to furnish the action against the erring officials responsible for allotting/assigning and giving permission for construction over forest land in violation of provisions under FC Act, 1980 along with name of officials of the State Govt. responsible for violation/responsible for allotment of the said forest land, which is still awaited.

Therefore, it is requested to furnish the information on the above observation of the Ministry along with information sought by this office vide letter dated 23.09.2022 to this office for further processing of the proposal.
