Sub: Diversion of 2.58 ha. (For approach road area 0.95 Ha and power line area 1.62 Ha) Forest land for non-forest purpose under the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 proposed for approach road from mines to Public Road and laying the power line in favour of M/s Shri. Bajrang Power & Ispat Ltd. Village Borjhara, Guma Road, Urla Industrial Area, Raipur in East- Bhanupratappur Forest Division, Kanker District in the State of Chhattisgarh-additional information required- reg.

Sir,

Kindly refer to the Government of Chhattisgarh letter no. F-5-07/2020/10-2 dated 11.03.2025.

The proposal has been examined by the Regional Office. It has been observed that certain important details are missing, which are necessary for further processing. These include:

- Clarification on the current status and usage of the 1.50 ha road area earlier diverted by the Central Government.
- Specifics regarding the 0.95 ha now proposed for road construction, including the actual extent presently in use and its purpose.
- Whether the previously diverted 1.50 ha forms part of the newly proposed 2.58 ha or is separate.
- KML file of the 1.50 ha road area already diverted.
- For the proposed 1.62 ha electricity line, details such as voltage, Right of Way (RoW), and the KML file.

Hence, the State Government is requested to submit the above-mentioned information/documents for further examination by the Regional Office.


