**विषय:** Diversion of 13.015 ha. of forest land in favour of NRSSXXXVI, Transmission Ltd., New Delhi for construction of 400 KV D/C Babai (RRVPL)- Bhiwani (PGCIL) Transmission Line in Jhunjhunu District.

**सन्दर्भ:** शासन सचिव (वन), राजस्थान शासन, जयपुर का पत्रांक - प01(20)वन/2018, दिनांक- 20.03.2018  
महोदया,

उपरोक्त विषय पर संदर्भित पत्र का आशय ग्रहण करने का कष्ट करें। जिसके द्वारा राज्य सरकार ने विषयांकित प्रस्ताव पर केन्द्र सरकार से वन [संरक्षण] अधिनियम, 1980 की धारा(2) के तहत स्वीकृति माँगी गयी है।

प्रस्ताव पर विचारोपरान्त मुझे आपको सूचित करने का निर्देश हुआ है कि राज्य सरकार निम्न बिन्दुओं पर आवश्यक सूचना प्रस्तुत करें-

- (a) Hard Copy of the proposal is without index and page numbers have been provided by a pencil.  
(b) Several documents of the proposal mere Xerox copies without authentication.
- As per A-3 xvii of part I, signature of authorized person needs authentication from competent authority for becoming authorized signatory on behalf of user agency.
- Information provided at B-2.4 component wise breakup of land requirement provides gross details. Details of forest land proposed for diversion on basis of project components shall be provided.
- As per the justification uploaded with the proposal at D-(i) in part I where involvement of wildlife reserve or conservation area (7.452 ha.) is clearly mentioned but the same vital facts are not reflected in Sr. No. 8 o part II specifically designated for information regarding "Wildlife Significance". The issue need clarification. The proposal may be segregated in two.
- The alternative provided at D-2(a) in part-I is incorrect. A slight change in alignment will avoid portion falling within Khetri PF which will reduce proposed diversion by 5.563 ha. This vital point needs justification.
- Documents from District Level Committee for FRA 2006 have not been uploaded at K-1(a) of part-I of the proposal.
- As per GIS DSS analysis of kml files following points regarding proposed forest land for diversion and proposed compensatory afforestation need revision:
  - Original toposheet from Survey of India needs submission.
  - Kml files have not been submitted in CD.
  - Kml files of proposed forest land diversion when overlaid on Google Earth show a shift with Right of Way.
- Additional document uploaded in part-I at Sr. 3 mentions diversion is of road side PF which is obligatory and unavoidable whereas documents provided at Sr. No. D part-I are showing analysis of three alternatives. This is contradictory and needs explanation.
- Detailed land schedule with basis of area calculation of proposed forest diversion has not been uploaded and land schedule provided in hard copy is without details.

10. (A) online enumeration list shows negative value in column 0-30 cm girth class which is incorrect.  
 (B) Diversion proposal for transmission line needs submission of two enumeratin lists, one for trees affected due to diversion and another trees to be felled.
11. Compensatory afforestation scheme has been proposed on double degraded forest land which is not as per provision contained in FCA handbook chapter 3. This exemption from equivalent non forest land is available to transmission lines upto 220 KV (3.2(vi)(c)) or Central Government/Central Government undertaking (3.2(ix)) which is not the case in this proposal as at A-2(xiii) of part I it is mentioned that user agency is private.
12. Site Inspection report of DCF is without mention of legal status of forest land proposed for diversion.
13. The proposal is without map showing location of transmission towers on forest and non forest land.
