महोदय,

उपरोक्त विषयान्तर्गत सन्दर्भित पत्र का आशय ग्रहण करते हुए मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरांत निम्नानुसार कार्यवाही राज्य सरकार स्तर से अपेक्षित पाई गई है:--

1. The state govt. may review and correct the employment information at para E (ii) & (iii), if needed.

- 2. State Govt. may quantify all parameters of the C/B analysis in monetory terms and accompanied with the ratio in the C/B analysis and submit to this office.
- 3. The KML of diversion area uploaded at para C appears incorrect. The mining area shown in the KML at para M-2 (vii) and the map submitted with approved mining plan is different from the map provided in KML of diversion area at para C. The state govt. may review the same and correct the KML and digital map of diversion area accordingly.
- 4. The information at para M 5.2 is not provided.
- The state Govt. may confirm that that proposed mining conforms to the DSR (as per EMSMG-2020 & SSM MG-2016 issued by MoEF&CC) of the concerned district.
- 6. The State Govt. may confirm the issue of riverine Wildlife biodiversity has to be fully addressed during the proposed mining as per direction given by CWLW.
- 7. On analysis of CA area, it is found that 1 ha is VDF and reaming in MDF. Therefore, the state govt. may replace this area with some suitable area having density less than 0.4.
- 8. The undertaking of mining lease holder is required that after ceasing mining operations he will undertake redressing the mining area and any other area which may have been disturbed due to their mining activities and restore the land to a condition which is suitable for growth of fodder, flora and fauna etc.

- 9. The CA scheme for area one and a half times of the safety zone area in degraded forest land be provided by the state govt.
- 10. Brief profile of lease & comments of state govt. may be required as per guideline para 7.8 (i) of the handbook.
- 11. The letter of intent was extended up to 21.08.2019 only. Therefore fresh letter of intent may be provided by the state govt.
- 12. It is mentioned in para H (i) Part-I that the application for Environment Clearance is yet to be submitted. User Agency should submit the application of EC immediately and report status to this office.
- 13. At para 8 (v), Part-II the DFO has mentioned 'yes' regarding rare/unique species availability in the proposed area further aquatic winter migratory birds like Ruddy, shelduck, littlegrebe etc visit area as per DFO Part-II in hard copy but nothing is mentioned about the adverse impact of mining on these. Therefore, comments may be submit alongwith mitigative measures if any, in this regard.
- 14. This is not clear that how the 'RBM' will be transported from the proposed site. Therefore, the status of approach road that will be used for the purpose may be given in details.
